

Focus on the Dispensing Doctors Fee Scale from 1 October 2009 – 1 April 2010
England & Wales

The General Practitioners Committee (GPC) and NHS Employers and have agreed a new fee scale for dispensing doctors, which will begin on 1 October 2009.

From 1 October the fee scale for dispensing doctors will be lowered by 8.7 per cent for the remaining six months of the financial year, representing a 4.9 per cent decrease across the whole year. From 1 April 2010 there will be an increase to produce a figure that is appropriate for the full new financial year.

The new mechanism splits the fee scale into two components – “cost” and “pay”¹. These components are balanced so that awards for dispensing doctors are comparable to the annual award that the Doctors and Dentists Review Body (DDRB) grants to all GPs, while allowing for the additional costs of the dispensing process. It works by increasing the “pay” in line with the DDRB annual award and uplifting the “cost” to reflect the annual national volume increases in dispensing.

The Department of Health have agreed to perform a ‘cost of service inquiry’ to gain a full picture of the costs of providing dispensing services. The inquiry will begin in early 2010.

The GPC is very disappointed at a decrease in the fee scale for dispensing doctors. Many patients in rural areas rely on dispensing practices to obtain their medicine and we are concerned that NHS Employers has underestimated the costs of the providing dispensing services, which inevitably rise with increasing volume.

The ‘cost of service inquiry’ should help develop a fairer cost analysis and reimbursement structure in future but, the government needs to act urgently to deal with the unilateral withdrawal of discounts by many of the drug wholesalers, which could threaten the viability

of some dispensing practices. GPC has made strong representations to the NHS Employers and the Department of Health about the loss of discounts and believes that the cost of service inquiry should begin immediately.
